A WORD FROM THE PRESIDENT/CEO

Friends,

As I sat and prepared to greet you, I found myself astounded to realize that St. Luke's House is now marking three-quarters of a year during which I have been privileged to serve as President/CEO. These months have flown in a flurry of introductions and activities, both within and outside of St. Luke's House. I am pleased to take the time to gratefully acknowledge the past year's accomplishments. That acknowledgement is well deserved and will serve as a stepping stone to facing the challenges ahead.

In the past year St. Luke's House has moved strongly forward toward successful completion of two very major projects.

The Electronic Health Records (EHR) team ably implemented core functions of the system and is now engaged in the development of the more customized systems components. St. Luke's House was recognized for our work on EHR and its role in supporting better integrated mental and physical health care for our clients. We presented the work at the Maryland Community Health Resources Commission Reception during the legislative session in Annapolis.

The Career Transition Program staff working on the Youth Transition Demonstration (YTD) Project, provide educational and vocational guidance and counseling to high school juniors and seniors, and recent graduates who have serious emotional disabilities. The YTD project, and its partnerships with families, employers, DORS, and Montgomery County Public Schools, was highlighted for Dr. Nancy Grasmick, State Superintendant of Schools, at Governor O'Malley's Capital For a Day program this summer. By the project's end, over 400 youth will receive services and the research data can be used to impact national policy.

In other areas, SLH staff, consumers, volunteers, and many community partners also continue to excel, to support one another, and to develop new opportunities.

St. Luke's House Evidence Based Practices, both Family Psycho-education Multifamily groups and Supported Employment practices, were honored with Mental Hygiene Administration awards for exemplary practice and assistance to other agencies in the state of Maryland.

Studio In-Sight expanded both participation in creative expression as well as exhibitions and community artistic partner-ships. Consumers' recently exhibited their art at a juried exhibition with Art Enables.

St. Luke's Church grew a beautiful and bountiful community garden this summer, the L.O V.E. garden, in which our Life Skills Program and consumers were encouraged to participate. The garden has yielded wonderful vegetables for many of our cooking classes, one of which was recently filmed on PBS.

These are a few of the more public examples of the spirit, dedication, and commitment of our organization. Other examples, less public, more quiet, abound and continue every day. All are essential and all come together to make SLH a beacon of light and hope, even in the tough economic times we are experiencing. The entire St. Luke's House community is now embarking on a several months long project of Strategic Plan development. We believe this is a critical juncture at which to assess where we are and where we would like to be over the next few years. I wish offer my sincere appreciation for our staff, consumers, and volunteers, and for the deep community support we receive. I truly believe this is our strength and it will enable us to meet the challenges ahead. I welcome the opportunity to hear from you as we work on strategic planning and will keep you updated as that plan takes shape by next Spring. I also look forward to personally meeting all of you.

Philip is currently a bagger at Giant Food and his supervisor praised his work ethic and his willingness and ability to take on new tasks. With the guidance of his job coach, he has learned more job skills and enhanced his

Strategic Planning for 2011-2014 has begun

St. Luke's House is has begun the process of Strategic Planning for the years 2011-2014. Colleen Luzier of HR Solutions and Ellyn McKay, private consultant, have been hired to lead St. Luke's House in developing a Strategic Plan for 2001-2014. The Board Executive Committee will serve, along with Cindy Ostrowski and the consultants, as a steering committee for the process. Seven Focus Groups made up of Board members, Executive Management Team, Program Managers, Supervisors and Specialists, Direct



service and administrative staff, family members, and consumers are now being formed to review the progress of the current plan, identifying our strengths and weaknesses and develop a plan for the 2011-2014. The process will be going on from October until April. Before finalizing the plan, there will be a retreat for the entire Board. the Management Team, and other invited stakeholders set initiatives, how they will be implemented, by which staff and within what timeframe.



The outcome will be given to the Executive Committee, The President/CEO and the consultants for finalization.




SLH 2011-2014

Swine Flu Prevention Measures

St. Luke's House has been implementing a plan for prevention of a Swine Flu outbreak in the agency. Eighty hand sanitizer dispensers have been purchased and installed in all of the houses and offices. Staff has been working with clients to Cover their cough, Wash their hands, stay home when they are sick.. Posters have been hung around in the offices and houses reminding consumers and staff alike to follow these procedures. We are also having all door handles, switches, remotes, etc. wiped down with sanitizer at least once a day. Each team has develop a plan for dealing with being short staffed and the Human Resource Department has reviewed the sick leave procedures to encourage staff to stay home when they are



sick. Dr. James Schmitt from NIH visited St. Luke's House to advise staff of the best procedures of prevention and treatment..



The first visit this year was when on May 29, Ray Thorn, Legislative Aide from Representative Chris Van Hollen's Office visited St. Luke's House for an information briefing and tour. Mr. Thorn was obviously aware of SLH and expressed the Congressman's appreciation for our work.

Board Chair Maggie Pearson joined some of the Executive

Staff on June 5 for a lunch roundtable and program tour for Dr. Richard Nakamura, Scientific Director at NIMH and Dr. Thomas Insel, Director of NIMH. Dr. Insel and Dr. Nakamura knew a great deal about St. Luke's House and were eager to learn even more. It was a pleasure and honor to further inform them about our agency.






BACK TO THE HILL


